#### QUARTERLY PROGRESS-TO-DATE REPORT FOR SPRING HILL METROPOLITAN DISTRICT NOS. 1-4 DATED: DECEMBER 18, 2024

Pursuant to HB24-1454, § 24-85-103(2.5), C.R.S., and 8 CCR 1501-11 Governor's Office of Information Technology Rules Establishing Technology Accessibility Standards (the "**Rules**"), Spring Hill Metropolitan District Nos. 1-4 (collectively, the "**Districts**") are required to provide a progress-to-date report that demonstrates concrete and specific efforts toward compliance.

The Districts have a plan in place with a goal to have all digital content remediated by July 1, 2025.
